## GUIDANCE NOTES:

### Section 1

#### **Normal home address**

For admission purposes this must be a residential property that is your child's only or main residence. It cannot be an address at which your child may sometimes stay or sleep due to your domestic arrangements. The property must be owned, leased or rented by the child's parents or person with parental responsibility. A child's normal home address is where they spend most of the week, unless it is accommodation at a boarding school. To avoid doubt where a child lives with parents/carers (with or without parental responsibility) whether for part of a week, or month, the address where the child lives will be determined by confirmation of the registered address to which Child Benefit is currently being paid.

### Section 3

#### **a) SEND & EHC Plans**
