Key Dates for priority appeals*

* A priority appeal is only for students applying to higher education who did not attain their firm choice (i.e. the offer they accepted as their first choice) and wish to appeal an A level or other Level 3 qualification result.

2. Procedural Error

- Clerical check that Special Consideration has been identified on School records
- Clerical check that the Department evidence/data includes any Special Consideration as identified above
- Clerical check that any Access Arrangements have been applied in March 2021 and May 2021 Assessments
- Clerical check on any additional Access Arrangement issues raised by the student/parent
- Clerical check that any reasonable adjustments have been applied
