# 4 ACCOUNTS 2019/20

The accounts and Trustees report 2019/20 had been previously circulated. Governors noted the RiF Committee had scrutinised the accounts, Landau Baker Auditors had attended the last RiF meeting and reported the financial controls are very good.

Governors approved the accounts 2019/20 on the recommendation of the RiF Committee.

#### 5 MONTHLY MANAGEMENT ACCOUNTS

The Chairman reported at the RiF Committee meeting, the Auditors recommended there is acknowledgement that the management accounts are reviewed by the Chairman of Governors each month with written feedback/approval sent back to the Resources Director. #### 6 ADMISSIONS POLICY 2022

The draft policy with amendments had been previously circulated. The Headmaster reported following earlier discussions, the policy now includes that six places in Year 7 are ring fenced for pupils who attract the pupil premium funding, with a lower entry score and the policy aligns with Aylesbury High School. Governors agreed this was a positive step and that the policy should go out for consultation and would come back to the next meeting to be determined.

## 7 HR EMPLOYMENT MANUAL

The Chairman reported the manual will replace all existing HR policies. The manual was drawn up by VWV, reviewed by the Headmaster and Mrs Miles and then a further review was undertaken with Mr Cobley and himself. The Headmaster reported the manual was also reviewed by the NEU representative, on the staff body, who made a couple of minor amendments. The Chairman asked if the Leave Policy, under maternity leave, covers any gender? The Headmaster responded VWV confirmed the use of the word "partner" is without gender. **Mr** Collins asked how staff will be made aware of the manual? The Headmaster responded it will be included in the Staff briefing on 7 December 2020 and a summary sheet of all the changes will be drawn up. The Chairman further reported the Pay Review Committee terms of reference will need to be updated to reflect the revised Pay Policy, this will be done alongside a recommendation to increase the scope of the Committee and will be come back to the next meeting.
